


NMRE Substance Use Disorder Treatment Admission Data


Heroin as Primary Drug

Percent of NMSAS 2002-14, NMRE 2015-2017 Treatment Admissions Reporting Heroin as Primary Drug




Prescription Opiates and Heroin

Percent of NMSAS 2002-14, NMRE 2015-17 Treatment Admissions Reporting Prescription Opiates or Heroin as Primary Drug




Michigan Mortality Rates by Age Group

In 2016, there were 2,335 overdose deaths in Michigan





Heroin and Opioid Related Drug Poisoning Deaths




People in Substance Use Treatment for Opioids in Michigan (DRAFT)





Substance Exposure Rate by Type NMRE Region


County Comparisons:

The counties with the highest exposure rates are:

- Crawford (72.10)
- Alpena (33.97)
- Manistee (30.97)

The counties with the lowest exposure rates are:

- Presque Isle (5.95)
- Oscoda (6.26)
- Missaukee (6.53)
- Montmorency (6.74)




Note. Row totals may not equal the sum of the row due to exposures with multiple substances. Rates for stimulants, sedatives, opiates, and anti-depressants represent the number of exposures per 10,000 aged 12 to 25. The ethanol rate represents the number of exposures per 10,000 aged 12 to 20.



According to the National Poison Data System, "the term 'exposure' means someone has had contact with the substance in some way; for example, ingested, inhaled, or absorbed a substance by the skin or eyes, etc. Exposures do not necessarily represent poisonings or overdoses."
